



GoMo Fibre Broadband “For Life” Promotion (May 2026)

1. These terms and conditions are in addition to the terms and conditions of the GoMo Fibre Broadband Service (the “**GoMo Fibre Broadband Service Terms**”) all of which are available at <http://www.gomo.ie/terms/> and together constitute a legally binding agreement between GoMo and the customer (“**you**”).
2. All capitalised terms herein (unless otherwise defined) shall have the meaning given to them in the GoMo Fibre Broadband Service Terms. In the event of any conflict between these terms and conditions and the GoMo Fibre Broadband Service Terms, these terms and conditions shall prevail.
3. The promotion comprises FTTH Fibre Broadband up to 500MB as set out in the GoMo Price List (the “**Promotion Price**”) which, subject to the below, will be applicable “For Life” (the “**For Life Promotion**”).
4. The promoter of this For Life Promotion is GoMo, with a place of business at 2 Heuston South Quarter, St John's Road, Dublin 8, D08Y42N, Ireland.
5. The For Life Promotion shall commence on 6 May 2026 and shall apply to the first 10,000 residential GoMo mobile customers (existing or new) who are eligible to receive the GoMo Fibre Broadband Service at their Home and who sign up to the For Life Promotion (“**Promotion Customers**”). The GoMo Fibre Broadband Service and the For Life Promotion are only available to residential consumers and are not available to business customers.
6. Residential GoMo Mobile customers may only avail of this For Life Promotion once, and a once-off activation fee as set out in the GoMo Price List shall apply to the For Life Promotion.
7. Where there are a number of active SIMS on a GoMo mobile account, only one residential address from that specific GoMo mobile account can avail of the For Life Promotion.
8. The For Life Promotion is made available subject to a 30-day minimum contract term being applied.
9. The Promotion Price offered to Promotion Customers as part of the For Life Promotion includes a monthly discount of €10.00 off the standard monthly price for the GoMo Fibre Broadband Service as set out in the GoMo Price List. If you terminate your GoMo mobile service at any time, this monthly discount will no longer apply and the Promotion Price will be increased by €10.00 to the standard monthly price as set out in the GoMo Price List, which will then become your new price “For Life”.

10. The For Life Promotion is available on the GoMo Broadband Network only and is not available on other network operator broadband networks. Your Home must be (1) located within a geographic area covered by our GoMo Broadband Network and (2) capable of a standard fibre broadband installation as determined by us. We may need to carry out a survey of your Home prior to installation.
11. You must continue to avail of the GoMo Fibre Broadband Service at the same premises in order to continue to avail of the For Life Promotion. If you move Home you will forfeit your entitlement to the For Life Promotion and it will automatically be terminated.
12. The For Life Promotion does not apply to Telephone or TV Services as such services are not provided as part of the GoMo Fibre Broadband Service.
13. GoMo reserves the right to amend, extend, vary or withdraw the For Life Promotion at any time and/or to vary or amend any element of the For Life Promotion at any time without further notice.
