



## GoMo Weekly Cash Prize Giveaway Terms and Conditions

1. These terms and conditions for a weekly cash prize ranging from a minimum of €1,000 up to a maximum of €2,500 as solely determined by GoMo (the “Giveaway”) are in addition to the terms and conditions of the GoMo service all of which are available at <http://www.gomo.ie/terms/> and all constitute a legally binding agreement between GoMo and the Customer.
2. All capitalised terms herein (unless otherwise defined) shall have the meaning given to them in the terms and conditions for the GoMo service. In the event of any conflict between these Giveaway terms and conditions and the terms and conditions of the GoMo service, these Giveaway terms and conditions shall prevail.
3. The organiser of this Giveaway is eircom Limited trading as GoMo with a place of business at 2 Heuston South Quarter, St John’s Road West, Dublin 8, D08 Y42N.
4. The Giveaway will run from 2<sup>nd</sup> December 2025 until 18th December 2026 (the “Giveaway Period”).
5. To participate in the Giveaway entrants must be an active GoMo Customer during the Giveaway Period, aged 18 and above, residing in Ireland and agree to these Giveaway terms and conditions.
6. To enter the Giveaway entrants must complete the Adobe form on GoMo’s website gomo.ie and:
  - (a) provide their first name;
  - (b) provide their GoMo mobile phone number;
  - (c) provide their email address;
  - (d) answer a trivia question about GoMo; and
  - (e) the entrant must have a valid and active SMS and email marketing preferences on their GoMo account.
7. During each week of the Giveaway Period entrants will be entered into a weekly draw for a cash prize of €1,000 or such higher amount up to a maximum of €2,500 as solely determined and notified to entrants by GoMo (the “Weekly Giveaway Prize”).
8. Entry for each Weekly Giveaway Prize draw during the Giveaway Period will end at midnight on the Wednesday of each week during the Giveaway Period.
9. GoMo will randomly select each of the Weekly Giveaway Prize winners from all eligible entries that have entered the Giveaway during the Giveaway Period, and each Weekly Giveaway Prize winner will be announced by GoMo on Friday of each week during the Giveaway Period.
10. Only active GoMo Customers are eligible for entry into the Giveaway. Each time a weekly Giveaway Prize winner is selected during the Giveaway Period, their eligibility shall be verified by GoMo to confirm they are an active / current GoMo Customer. If the Giveaway Prize winner is no longer a GoMo Customer, they will be disqualified, and a new Giveaway Prize winner will be selected. Additionally, the pool of GoMo Customer entrants shall be reviewed monthly by GoMo, and any individuals who are no longer GoMo Customers will be removed from the Giveaway.

11. Each Weekly Giveaway Prize will be in the form of a cheque, which will be issued by eircom Limited which trades as GoMo.
12. The Weekly Giveaway Prize is non-transferable, and the Weekly Giveaway Prize winners may not transfer their Weekly Giveaway Prize to any other person.
13. The Giveaway will be moderated by GoMo and only legitimate entries will be accepted for entry, no inappropriate entries will be counted. It is the responsibility of the entrant to provide their correct, up-to-date details when entering the Giveaway and/or confirming acceptance of the Weekly Giveaway Prize for the Weekly Giveaway Prize to be processed. Entries that are incomplete or in violation of these Giveaway terms and conditions will be disqualified. Only one entry is allowed per GoMo Customer. Proof of entry does not constitute proof of receipt. Anyone found to be using multiple accounts to enter the Giveaway will be deemed ineligible to enter the Giveaway.
14. GoMo reserves the right to request proof of a Weekly Giveaway Prize winner's identity and age, and confirmation that the Weekly Giveaway Prize winner is an active GoMo Customer. If a Weekly Giveaway Prize winner cannot provide GoMo with such proof as reasonably acceptable to GoMo, GoMo may withdraw the Weekly Giveaway Prize and select another Weekly Giveaway Prize winner.
15. Each Weekly Giveaway Prize winner will be initially contacted by GoMo via phone call from a member of the GoMo team to the contact number provided by entrants at the point of the entry to the Giveaway, followed by an email. Only one attempt to contact a Weekly Giveaway Prize winner(s) will be made by GoMo and to be able to win the Weekly Giveaway Prize, the selected entrant must answer their phone when called by GoMo or contact GoMo within 24 hours of being notified. Failure to respond within this time frame will result in forfeiture of the Weekly Giveaway Prize and selection of an alternate Weekly Giveaway Prize winner. If the selected entrant answers the call and accepts the Weekly Giveaway Prize they will win the Weekly Giveaway Prize. If the selected entrant does not answer their phone, they will not win the Prize and GoMo will conduct a second draw to select a second entrant. The second entrant will then be able to win the Prize in the manner described in these Giveaway terms and conditions. That process will be repeated until a selected entrant answers their phone accepts the Prize.
16. GoMo will not be responsible for any inability of a Weekly Giveaway Prize winner to take up or claim the specified Prize.
17. GoMo reserves the right to publish the first name and any testimonial of each Weekly Giveaway Prize winner on its official website ([www.GoMo.ie](http://www.GoMo.ie)) and across its social media channels, including but not limited to Instagram, Twitter (X), and Facebook.
18. Employees of GoMo who are directly connected with the creation and administration of the Giveaway and members of their immediate families are not eligible to enter the Giveaway.
19. In the event of any dispute regarding the rules, conduct or the results of the Giveaway, the decision of GoMo will be final and binding and no correspondence will be entered into.
20. Acceptance of the Weekly Giveaway Prizes by each of the Weekly Giveaway Prize winners constitutes consent to use the relevant Weekly Giveaway Prize winner's name and likeness (general location/county) for purposes of advertising, promotion or publicity in any media without additional compensation and each Weekly Giveaway Prize winner agrees to take part in such related promotional activities as GoMo requires.

21. GoMo will also use a summary of the entrant's comments for the purpose of entering this Giveaway as testimonies on its website [www.GoMo.ie](http://www.GoMo.ie) including the customer first name only.

Entrant details are captured for the sole purpose of (1) entering into the Giveaway and (2) for keeping entrants informed of: (i) exclusive GoMo promotions and competitions (ii) promotions, products and services from GoMo's select third party partners (iii) promotions, products and services from other GoMo group companies and (iv) market research. Except as outlined in these Giveaway terms and conditions entrant details will not be used for any other marketing purposes and will not be disclosed to any third parties by GoMo except in instances where GoMo is required to engage its delivery partner where necessary and appropriate to deliver Weekly Giveaway Prizes to each of the Weekly Giveaway Prize winners. GoMo will delete all entrants' data provided for the purpose of this Giveaway 30 days after the conclusion of the Giveaway Period save for (i) any details used in an ongoing capacity where a relationship exists between the entrant and GoMo, (ii) the entrant hasn't opted out from receiving marketing communications from GoMo (iii) the entrant ceases to be GoMo Customer or (iv) the entrant has opted out from the Giveaway during the Giveaway Period [and no longer wishes to receive marketing communications from GoMo].
23. Entrants who wish to be removed from the Giveaway can do so by logging into their MyGoMo account and opting out of all communications. Entrants who simply wish to opt out of the Weekly Giveaway draw only may remove their entry from the Giveaway only at any time by contacting GoMo Customer Care at GoMo.ie or via social media - Facebook and twitter (X).
24. GoMo reserves the right to cancel, terminate, modify or suspend the Giveaway and/or vary Giveaway terms and conditions at any time without prior notice.
25. Participation in the Giveaway denotes acceptance of these Giveaway terms and conditions and any additional Giveaway specific terms and conditions, which may be advertised.
26. GoMo is not responsible for any delay or cancellation of any element of the Weekly Giveaway Prize or for any inability of the Prize winner to take up the Prize.

GoMo does not accept any responsibility or liability whatsoever for any technical failure or malfunction or any other problem in any network, system, server, provider, delivery service or otherwise which may result in entries being lost or not properly registered or recorded and entrants hereby waive any claim whatsoever for any losses, costs, damages and expenses arising from any such problems. By participating in the Giveaway, participants release GoMo from any liability whatsoever for any claims, costs, injuries, losses, or damages of any kind arising out of or in connection with the Giveaway or the acceptance, possession, or use of the Prize.

If any part of these Giveaway terms and conditions are held by a court of competent jurisdiction to be illegal or unenforceable, the validity or enforceability of the remainder of these Giveaway terms and conditions shall not be affected and such provision shall be deemed modified to the minimum extent necessary to make such provision consistent with applicable law and, in its modified form, such provision shall then be enforceable and enforced.
29. These Giveaway terms and conditions shall be governed by the laws of Ireland and are subject to the jurisdiction of the Irish Courts
